# All you need to know about the Peep Progression Pathway



# **1** Introduction

Thank you for participating in the Peep Progression Pathway. We hope you will enjoy the experience and knowledge gained through:

- completing your keepsake book (assessed portfolio)
- taking part in the group
- finding out how the everyday things you already do with your child helps support their development
- building on these experiences

# 2 What is the Peep Progression Pathway?

The Peep Progression Pathway was created by Peeple, a charity that supports parents and carers to learn together with their child(ren). It is made up of a number of units (sometimes referred to as 'programmes' or 'courses') that are offered through your local Peep sessions. These units are offered on a range of topics relating to child development and the learning children already do every day at home with their families.

The units are open to **everyone** and are recognised on a framework called the SCQF (Scottish Credit and Qualifications Framework) which shows the different levels of learning. The units are offered at three different levels – SCQF Level 3, 4 and 5 in Scotland, or entry level 3, level 1 and 2 equivalent in the rest of the UK (*more on this later - Section 5*).

Support will be given to anyone who needs a hand with reading or writing and your Peep practitioner will be there to guide you whenever you need it. If there is anything else you would like to tell us (in confidence) that you feel will help us to support you, please have a chat with your Peep practitioner.

# 3 What to expect

To participate in the Peep Progression Pathway you will need to:

- attend the Peep sessions with your baby or child
- work your way through completing a Keepsake Book showing how you and your baby/child are learning together. (Note: this may sometimes be referred to as an assessed portfolio, but we prefer to call it a 'Keepsake Book'.)

#### **Peep Sessions**

The Peep Progression Pathway is delivered through Peep sessions that happen regularly over a number of weeks (dates confirmed by your Peep practitioner). In order to participate in the Peep Progression Pathway, you should be able to attend all, or most of the Peep sessions. We understand that things come up, and you may need to miss a couple of sessions. You will still be welcome to participate in the Peep Progression Pathway and there will be an opportunity to catch up on missed sessions.

#### Keepsake Book

During or after the group, you will work your way through completing a keepsake book. The keepsake book will provide memories of important milestones and events in your child's life, and your reflections on the learning together you *already* do in everyday life at home. We'd love for you to personalise it by adding photos, drawings and anything else you feel is meaningful. Your Peep practitioner will share information during the sessions that will help you to complete your keepsake book. You will also have the opportunity to share experiences with other learners, which will be useful for answering the questions in your keepsake book.

Your Peep practitioner will regularly take a look at your keepsake book to make sure you're on the right track and to guide you on how to add more detail to your book if needed.

#### 4 How the course will be delivered

The course will be delivered by a Peep practitioner and will include songs (you don't have to sing if you don't feel comfortable), stories, activities and a talk time. The talk time is when the Peep practitioner will have a chat about a topic relevant to child development (for example, becoming a talker or making marks), and you and the other learners can share your experiences and learn from each other!


You are welcome to take your keepsake book home to work on – please remember to bring it back the following week! Your Peep practitioner may also offer opportunities to complete some of the pages during the sessions too. Have a chat with your practitioner if you have difficulties finding the time to work on your keepsake book – they might have some ideas that will help you.

## 5 Getting your certificate

Once you have completed your keepsake book, and the Peep practitioner has checked it over, it will go to a Peep manager to double-check. If no changes are needed, your details will be registered to receive a certificate. Completion of your course will give you something called a 'credit -rated unit' and is worth either 2, 3 or 4 'credit points'. The number of credit points shows a value for the length of time you have worked on the unit.

The units have been credit-rated by the Scottish Qualifications Authority (SQA) and recognised by Ofqual on the Regulated Qualifications Framework (RQF) which accredits qualifications in England, Wales and Northern Ireland. These frameworks are used widely by colleges and employers, and show what level of learning you have achieved.

### 6 What could you progress on to?



'After completing the Pathway course I volunteered at a Peep group, assisting with the running of the group. This was great experience and helped my confidence grow. When I returned to work after maternity leave I decided to retrain and change careers. I attended the Peep Learning Together Programme training to become a Peep Leader. Now, two and a half years later, I have new skills and more confidence as a parent and a Peep leader!' Parent

Co-deliver Peep sessions	Speak to your Peep practitioner to see if it's possible for you to help deliver Peep in your area. Some parents/carers have chosen to do this through volunteering, and others have found paid employment co-delivering Peep sessions.

Further Education	<ul> <li>Peeple has set up agreements with local colleges to offer guaranteed interviews and, in some cases guaranteed places on childcare and health &amp; social care courses. Some colleges have full-time and part-time options available to suit your needs. College agreements are for learners who have completed two Peep Progression Pathway units – speak to your Peep practitioner for more details on college agreements. If you are considering attending further education we also recommend that you contact student services within the college to seek advice on finances and childcare.</li> </ul>	
Employment	<ul> <li>Through the Peep Progression Pathway, you will be able to build on skills that are needed in the workplace - problem solving, completing a project, working with others etc. These skills can be used in a very wide variety of work settings, and can be added to your CV (curriculum vitae). We know that the types of work you may be interested in will differ greatly. # 7 How to explain the Peep Progression Pathway to an employer or an education provider (for example, college)

It is important to know how to communicate your learning to an employer or education provider so that they understand what you have achieved. This can be done in two ways:

**CV** You should record the Peep Progression Pathway within the 'education' or 'training' sections of your CV and you would list the unit as it is on your certificate for example, *SCQF Level 3 unit Development of Babies* or *SCQF Level 4 unit Communication and Language (Toddlers).* 

Job /Within an application, you should provide examples of how you meet theCollegeessential and desirable criteria within the job advert. You can use an exampleapplication /from the Peep Progression Pathway if you choose – perhaps something aroundInterview'working with others'. You may want to include something along the lines of:

'I attended Peep sessions for x months. Peep is a family learning programme where parents/carers learn together with their children on a variety of topics relating to child development. As part of the Peep sessions I was involved in group and 1-1 discussions relating to my experiences of learning together with my baby/child. Through this I have developed my communication skills – both speaking and listening, and feel that I am better equipped to support others and respect their ideas and opinions. As a result I not only learned x about my child and how to improve learning at home, but I also successfully completed an SCQF Level 5 unit in Early Maths relating to Toddler Development'

It's important when completing your CV, an application or interview that you are specific with the length of time you were learning, who was involved and what the result was. A useful tool in building examples to use these situations is the STAR Technique (Situation, Task, Action, Result). # 8 How do I get started and what else do I need to know?

To get started, all you need to do is complete the **Learner Registration and Declaration** – you may have been given one with this Handbook, if not then ask your Peep Practitioner for a copy. The following table will show you how we will handle your data:
